




- Alcohol-involved deaths are nearly 4 times higher than opioid deaths.


Cheap Liquor Increased Adult & Youth Drinking More Alcohol-Related Harms

Alcohol and Cancer

Big Alcohol has lobbied to keep cancer warnings, serving sizes, and other information off of alcohol products. It has been proven that alcohol consumption leads to cancer, including breast and colon cancer.

lowa has the 4th highest incidence of alcohol-related cancers in the U.S. and the highest rate in the Midwest!



THE SOLUTION: A small increase in the price of the cheapest liquor will improve the health of individuals and increase community safety.



THE POLICY:

A Minimum Unit Price (MUP) policy for high content by volume liquor in Iowa.



A Minimum Unit Price is set for any given container of liquor addressing the price of only the cheapest liquors in Iowa

A WIN FOR







Even the playing field for Iowa Distillers who are competing with large out-of-state manufacturers.

More funds raised for Iowa to help pay for the harms caused by excessive drinking.

It would only affect the cheapest 10% of the 2500 products sold in Iowa.

Minimum Unit Price will:

REDUCE: Underage Drinking

Excessive Adult Consumption
Alcohol-related Illnesses
Alcohol-related Cancers
Alcohol-related Car Crashes
Violence/Violent Crimes
Alcohol-involved Deaths

Enhance Equity:

Studies have found that, while higher-income households may consume equal or greater amounts of alcohol overall, lower-income households "bear a disproportionate burden of negative alcohol-related consequences," especially lower-income communities of color.

Researchers in Scotland found in 2023 that a minimum unit price policy being utilized in Scotland was associated with a significant reduction in alcohol-specific deaths.

What if this policy is not adopted?



Alcohol-related illnesses and deaths will continue to grow in Iowa!
